

Report on the Firm's System of Quality Control

We have reviewed the system of quality control for the accounting and auditing practice of Gold Gerstein Group, LLC (the firm) in effect for the year ended May 31, 2018. Required Selections and Considerations

Engagements selected for review included Audits of employee benefit plans, Audit performed under *Government Auditing Standards*, and an Examination of service organization (SOC 1).

As a part of our peer review, we considered reviews by regulatory entities as communicated by the firm, if applicable, in determining the nature and extent of our procedures.

Opinion

In our opinion the system of quality control for the accounting and auditing practice of Gold Gerstein Group, LLC in effect for the year ended May 31, 2018, has been suitably designed and complied with to provide the firm with reasonable assurance of performing and reporting in conformity with applicable professional standards in all material respects.
